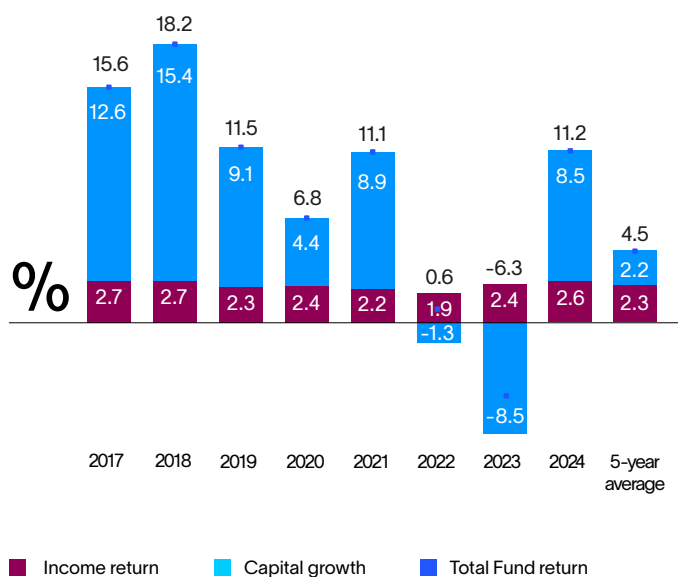


Fund strategy and facts

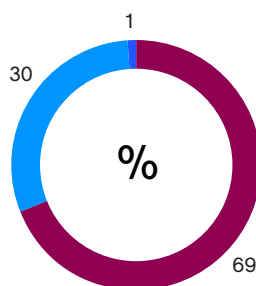

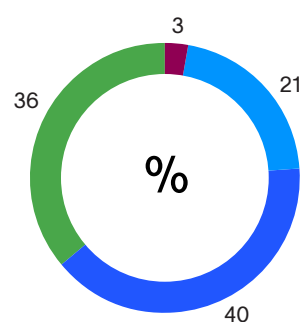
Portfolio composition YE 2024
